ID-AYU0819) with 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020 from the academic session 2023-24-reg.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

1. I am to refer to your application, scheme vide ref no. **BESCT/Coveringletter/2022-23/19 dated 19.10.2022 received from The Chairman, Bhartiya Education Social Charitable Trust, At- Velshet, Po-Pigonde, Nagothane, Tal-Roha, Dist-Raigad, 402106, Maharashtra** on the subject cited above and to verify the available facilities of teaching and practical training **for the intake capacity with 100 seats in UG (BAMS) course from the academic session 2023-24**, the college was visited on **10.10.2023 & 11.10.2023 on hybrid mode** for issuance of LOI by the visitation team of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) and as per direction of competent authority letter of intent has been issued you vide letter of even no. dated **19.10.2023** to establish new Ayurveda college in the name of **Shreemati Shantibai Otarmal Jain Ayurvedic Medical College At Velshet, PO- Pigonde, Nagothane, Tal-Roha, Dist-Raigad, 402106, Maharashtra (Inst. ID-AYU0819) for intake capacity with 100 seats in UG (BAMS) course under Section 29 of NCISM ACT 2020 from the academic session 2023-24.**
2. The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) had carried out an inspection of the institution again on **07.11.2023 and 08.11.2023 through Hybrid mode** to assess the available facilities of teaching, non-teaching, hospital staff and to verify the physical and other infrastructure facilities available for issuance of Letter of Permission (LOP) to establish new Ayurveda college in the name of **Shreemati Shantibai Otarmal Jain Ayurvedic Medical College, At- Velshet, Po-Pigonde, Nagothane, Tal-Roha, Dist-Raigad, 402106 Maharashtra with 100 seats in UG (BAMS) course** under section 29 of NCISM Act 2020 from the academic section 2023-24 and relevant regulations thereunder.
3. In view of above as per the direction of **President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM)**, the assessment report and all other related documents were placed in the **70th Board Meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **16.11.2023**. Board decided to issue letter of Permission **to establish new Ayurvedic Medical college with intake capacity of 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020 from the academic session 2023-24.**

4. Further, in accordance of Section **6 (1) (i) (ii)** of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019, Vide letter of even no. dated **16.11.2023** a letter was sent to you to furnish Fixed security deposit **worth Rupees 02 Crore (Two crore)** in favour of National Commission fund for Indian System of Medicine for the period of five years. In response of the same you have furnished the fixed security deposit amount **of Rupees 02 Crore (Two crore)** in favour of the National Commission fund for the Indian system of Medicine through **Cheque No 656957 dated 02.11.2023 from the State Bank of India, and informed the same vide an email dated 02.11.2023 enclosing a letter vide ref MES/MAC/FSD/2023/02 Dated 02.11.2023.**
5. Therefore, **Letter of Permission (LOP) is issued to The Chairman, Bhartiya Education Social Charitable Trust, At- Velshet, Po-Pigonde, Nagothane, Tal-Roha, Dist-Raigad, 402106, Maharashtra to establish new Ayurvedic Medical college in the name of Shreemati Shantibai Otarmal Jain Ayurvedic Medical College At Velshet, PO- Pigonde, Nagothane, Tal-Roha, Dist-Raigad, 402106, Maharashtra (Inst. ID-AYU0819) with 100 seats in UG (BAMS) course under Section 29 of NCISM ACT 2020 from the academic session 2023-24 and relevant regulations thereunder subject to the following conditions: -**
 - I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
 - II. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of **100 seats** shall be treated as all India quota. The counselling for seats under all India quota shall be conducted by respective counselling authority as designated by Central Government for A.Y. 2023-24 and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.
 - III. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
6. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
7. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
8. **The following requirements should be fulfilled by the college by 31st December, 2023 to get permission for the academic session 2024-25:**
 - i. The applicant shall fulfill all the requirements of infrastructure for teaching and training facilities as specified in "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016";
 - ii. The applicant shall fulfill all the relevant provisions of Regulations namely the "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and increase of Admission Capacity by a Medical College Regulations, 2019"
 - iii. The applicant shall fulfill all the requirements of the "Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016";
 - iv. The applicant shall fulfill all the relevant provisions under the NCISM Act, 2020.
9. The College administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the NCISM ACT and relevant regulation thereunder, are in position before the admission of the first batch of students in the 1st professional of BAMS is made, under intimation to the Medical Assessment and Rating Board, NCISM.
10. Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.

11. The college has to develop the requisite infrastructure for I, II and III professionals well in time as per the norms which will be verified by the medical assessment and rating board and accordingly the permission for taking admissions in subsequent academic session will be considered.
12. The college administration may take up the matter for recognition of the qualification under section 35 of the NCISM Act, 2020 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
13. The fulfillment of the condition given above may be made within the time period specified and compliance report should be submitted by the college to medical assessment and rating board for Indian system of medicine. The medical assessment and rating board for Indian system of medicine will verify that the conditions have been fulfilled for considering the permission matter for the academic session 2024-25.

- a) **Availability of teaching staff is $\frac{\text{Available}}{\text{Required}} \times 100\% = \frac{8}{10} \times 100\% = 80\%$ which is not fulfilling the criteria as per Sub Regulation (1) (a) of Regulation 8 and Schedule-V of MSR 2016.**



As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the **86th Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **03.05.2024** and **Board concluded that the college is not fulfilling the notified & approved criteria, but fulfilling the criteria required for issuance of permission as per the Regulation 3 of MSR 2016 and as per the note mentioned in Schedule-V, Schedule-VI and Schedule-IV of MSR 2016. Hence, Board decided to issue the renewal of permission with 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020 for the academic session 2024-25.**

Sir/Madam,

- 1) To assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college namely **Shreemati Shantibai Otarmal Jain Ayurvedic Medical College, At -Velshet, Po-Pigonde, Nagothane, Tal-Roha, Dist- Raigad, 402106, Maharashtra (Inst. ID-AYU0819)** inspection was conducted on **08.04.2025 and 09.04.2025 in hybrid mode** as a part of annual visitation by the visitation team of Medical Assessment and Rating Board, NCISM to process **2nd renewal of permission with intake capacity of 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020 for the academic session 2025-26.**
- 2) The visitation report and all other related documents were assessed in terms of enforced regulations namely the Minimum essential standards, assessment and rating for undergraduate Ayurveda colleges and attached teaching hospitals Regulations, 2024 ", MESAR PG Ayurveda 2024, provisions under the NCISM Act, 2020 and relevant Regulations there under and **defects/ shortcoming were found in the assessment and was informed to you vide letter of even no. dated 21.06.2025. In response of the same, you have submitted the clarification vide an email dated 26.06.2025.**
- 3) Accordingly, the submitted clarification and the assessment report was once again carefully examined in terms of concerned Acts & Regulations and provision under the NCISM Act, 2020 and relevant regulations and the assessment report along with the clarification was placed in the **134th Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) on **16.07.2025** On careful examination of the assessment report and the submitted clarification , considering the deficiencies observed therein Board decided to provide an opportunity of hearing to the college and same was communicated to you vide the MARBISM letter (Hearing notice) of **even no. dated 19.07.2025** to appear on **21.07.2025** before the designated Hearing Committee to present their case and to show cause as to **why not the permission to your college with with intake capacity of 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020 for the academic session 2025-26 be denied.**
- 4) The college was directed to make written submission in respect of the case and produce all relevant valid documents/records/proof against all the deficiencies/shortcomings as indicated in the hearing letter. The representatives of the college submitted written submissions **vide letter. no. SSOJAMCR/2024-25/547 dated 19.07.2025** against the deficiencies conveyed to them. Whereas, the college through its representatives **Hearing was attended by Vd Jyoti Manoj Jagtap, Dean** appeared before the Hearing Committee on **21.07.2025** and made their submission virtually as well as written submission against the shortcomings communicated to the college. **The shortcomings communicated to the college, submission made by the representatives of the Ayurveda college and observations made by the Hearing Committee are as under:-**

- 5) The observation of hearing committee based on the submission made by the college representatives during hearing and assessment report of the NCISM have been carefully re-examined in terms regulations, namely, "Minimum Standard of infrastructure and teaching & training facilities as specified in the NCISM (Minimum essential standards, assessment and rating for undergraduate Ayurveda colleges and attached teaching hospitals) Regulations, 2024, and provisions under the NCISM Act, 2020, the recommendation of Hearing Committee was once again placed in the **136th Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) **held on 24.07.2025 and Board concluded that the college is fulfilling the notified & requisite criteria for issuance of permission as per the Concerned Acts and regulations . Hence, the Board decided to issue 2nd renewal of permission with intake capacity of 100 seats in UG (BAMS) course in accordance with Regulation 64 (3) of MESAR UG Ayurveda 2024, under section 29 of NCISM Act, 2020 for the academic session 2025-26.**

"DECISION"

- 6) **Therefore, 2nd renewal of permission is hereby granted to Shreemati Shantibai Otarmal Jain Ayurvedic Medical College, At -Velshet, Po-Pigonde, Nagothane, Tal-Roha, Dist- Raigad, 402106, Maharashtra (Inst. ID-AYU0819) with intake capacity of 100 seats in UG (BAMS) course in accordance with Regulation 64 (3) of MESAR UG Ayurveda 2024, under section 29 of NCISM Act, 2020 for the academic session 2025-26 subject to the condition that following requirements shall be fulfilled: -**
- I. **Minimum 15% of undergraduate seats of the permitted intake capacity of 100 seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2025-26 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
- II. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
- 7) Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
- 8) **Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.**
- 9) Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- 10) **Compliance of all the requirements of Aadhaar Enabled Biometric Attendance System as mentioned in the Implementation letters vide. Ref. no. 3/2024/MARB/AEBAS & HMS. Dated 09.05.2024 & 06.09.2024 issued by the Board.**
- 11) **The following requirements must be fulfilled and the compliance report must reach the Board by 30th November, 2025 to be considered for the issuance of permission for the academic session 2026-2027:-**
- i) All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled.

- ii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in NCISM (Minimum essential standards, assessment and rating for undergraduate Ayurveda colleges and attached teaching hospitals) Regulations, 2024.
- iii) All the requirements of the National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education) Regulations-2022.
- 12) The College administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the NCISM ACT and relevant regulation thereunder, are in position before the admission of 3rd batch of students in the 1st professional BAMS is made under intimation to the Medical Assessment and Rating Board, NCISM.
- 13) The college has to develop the requisite infrastructure for I, II and III professionals well in time in accordance with the Regulation (66) of MESAR 2024 which will be verified by the medical assessment and rating board and accordingly the permission for taking admissions in subsequent academic session will be considered.
- 14) The college administration may take up the matter for recognition of the qualification under section 35 of the NCISM Act, 2020 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
- 15) The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college within the timeline as mentioned above to the President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the renewal of permission for the academic session 2026-27.
